



# Crime Scene Documentation/Photography

Marking items of interest and documenting them through proper photography are important steps to preserve evidence and keep the integrity of the investigation.

- Methods to properly document a crime scene include:
- Photography. All photos must be done with and without scale.
  - Sketching. Helps enhance documentation and eyewitness accounts.

In this section, you'll find the tools to properly photograph and document crime scenes and help detail eyewitness accounts.



### Crime Scene and Evidence Photography

Photography remains the least developed skillset for arson and crime scene investigators. Failure to obtain good images of evidence while at the crime scene or in a lab, will likely result in the photograph not being accepted by the court and deemed unsuitable for presentation to the jury.

Crime Scene Sketching

Crime scene photography is a two-dimensional view of the scene and might not provide measured information about the distances between objects. A finished drawing or rough sketch of the scene is the most effective way of showing actual measurements and identifying important items of evidence.

Sketches are separated into three classes:

- **Rough Sketch.** After all the photography is collected and before any evidence is collected, investigators prepare this sketch at the scene. The sketch doesn't have to be drawn to scale but should have exact measurements of the surroundings and where evidence is in relation to the victim's location.
- **Finished Sketch.** The finished sketch is a duplicate of the rough sketch but prepared to scale using layout templates and exact distances.
- **Scale Drawing.** A scale drawing is used primarily for courtroom presentation and it may be drawn to any scale chosen. It should include all measurements of the rooms, furniture, walls, etc., but not the location of recovered evidence. When the drawing is complete, a clear plastic overlay can be attached to show where evidence is located.
