





Visible Stain Detection



- If the object is porous, such as paper, cardboard, textile products, it will be permanently discolored.
- Non-porous materials, such as steel and glass, can usually be restored and cleaned.
- Do not use powders where there is an air flow. Airborne stain detection particles can contaminate large areas. Only use visible stain paste in this situation.
- When in doubt, use only non-destructive fluorescent invisible detection materials.
- **Note:** Visible Stain Detection Products cannot be removed from porous surfaces. Non-porous objects may usually be cleaned.

Visible Stain Detection Powder

Visible Stain Powders react to moisture such as perspiration, skin oils and water with a vivid color change. Once transfered to the skin of a subject, this color reaction is difficult to remove,—washing of the hands will only make the vivid color stain spread and intensify. Match the natural color of these powders to blend with the surface of application.

You can use detection paste indoors or outdoors, regardless of air flow. Wear gloves when you apply a thin layer of paste to a similar color object. Once the paste comes into contact with moisture, including perspiration, skin oils or water, the paste will react and a vivid color will appear. Note: Visible Stain Detection Products cannot be removed from porous surfaces.




